

THE CCCI LIFE MEMBERSHIP REQUIREMENTS

Life Membership is a membership available to any member who is a US Resident. The nominee must have been a member of the Club for twenty-five consecutive years and must have rendered exceptional service to the Club or the breed in order to be awarded Life Membership by the Board of Directors. The Board of Directors may approve up to 4 new Life Members in a calendar year. Life Members retain all the rights and limitations of their Resident type of membership but do not pay annual dues.
